The Lakes at Centerra Metropolitan District Nos. 1-3 (the "Districts") have conducted regular monitoring and scanning of their information and communication technology ("ICT"), as such term is defined in 8 CCR § 1501-11.4, as further described below:

Using Streamline's Technical Standards-compliant web hosting platform, monthly scans of
the Districts' website content are conducted via the Accessibility Dashboard to ensure
adherence to the Technical Standards. These scans evaluate various aspects of the website,
including text readability, image alt text accuracy, file compliance, and screen reader
compatibility. Detailed reports are generated to identify any issues or areas needing
improvement, allowing the Districts to promptly address technology accessibility concerns
and maintain an inclusive online presence.

The results of the regular scanning and monitoring show the Districts' ICT having an overall compliance score of 81% with the Technical Standards, as such term is defined in 8 CCR § 1501-11.5. The Districts continue to remediate known compliance issues in the following areas:

- PDF remediation to achieve compliance with the Technical Standards. This includes adding proper tags for structure, providing descriptive alternative text for images, ensuring logical reading order, embedding fonts, and optimizing color contrast.
- The Districts are aware that the www.lakesatcenterramd.com website is currently not compliant with the Technical Standards. To address this, the Districts are in the process of transitioning the Districts' website located at www.lakesatcenterramd.com to Streamline, a web hosting platform meeting the requirements of the Technical Standards. The Streamline platform offers robust features that enhance accessibility, including improved screen reader compatibility, better keyboard navigation, clear and concise alternative text for images, and optimized color contrast for readability. The Districts are committed to achieving compliance with the Technical Standards through regular monitoring, updates, and staff training to uphold technology accessibility best practices.
